1 **1. Appreciation**

2  
3 WHEREAS, the apostle Paul reminds us to “give thanks in everything” (1 Thessalonians 5:18), and to honor those who labor  
4 faithfully for the sake of the Gospel; and

5  
6 WHEREAS, Taylors First Baptist Church, under the leadership of Pastor Josh Powell, has graciously opened its doors  
7 and extended warm hospitality to the messengers and guests of the 205th Annual Meeting of the South Carolina Baptist  
8 Convention on November 10–11, 2025, so that we might “Celebrate” all that God is doing amongst our Convention (Psalm  
9 126:3); and

10  
11 WHEREAS, the staff and volunteers of Taylors First Baptist Church have given of their time, energy, and resources to  
12 provide a welcoming environment for worship, fellowship, and the business of our Convention; and

13  
14 WHEREAS, the facilities of Taylors First Baptist Church have been prayerfully and excellently prepared to support the work  
15 of South Carolina Baptists as we gather together for the glory of God and the advancement of his Kingdom; therefore, be  
16 it

17  
18 RESOLVED, that we, the messengers to the 205th session of the South Carolina Baptist Convention meeting in Taylors,  
19 South Carolina, November 10–11, 2025, joyfully express our gratitude to Pastor Josh Powell, the staff, and the entire church  
20 family for their gracious hospitality and faithful service to Christ and his church; and be it finally

21  
22 RESOLVED, that we pray God’s continued favor and blessing upon Taylors First Baptist Church as they serve their  
23 community, our state, and the nations with the Gospel of Jesus Christ.

1 **2. Encouraging a Faithful Biblical Witness in the Face of Violent Attacks Against Free Speech**

2  
3 WHEREAS, Scripture teaches that every human being has immeasurable worth because he is created by God as his image  
4 bearer (Genesis 1:27); and

5  
6 WHEREAS, the Lord Jesus Christ commanded his followers to love their enemies and pray for those who persecute them  
7 (Matthew 5:44); and

8  
9 WHEREAS, free speech in the public square provides the opportunity for humanity to hear and consider truth claims that  
10 shape the conscience, and Scripture calls us to “test all things; hold on to what is good” (1 Thessalonians 5:21) and to  
11 “take every thought captive to obey Christ” (2 Corinthians 10:5); and

12  
13 WHEREAS, violent attacks against free speech disregard human dignity, undermine civil society, and contradict the Gospel  
14 of peace (Romans 12:17–18); and

15  
16 WHEREAS, public discourse is increasingly marked by hostility, division, and threats against those who speak  
17 courageously from biblical convictions; and

18  
19 WHEREAS, the Christian witness flourishes when believers stand firmly for truth with compassionate conviction, even in  
20 the face of opposition (Philippians 1:28); therefore, be it

22 RESOLVED, that the messengers to the 205th session of the South Carolina Baptist Convention meeting in Taylors, South  
23 Carolina, November 10–11, 2025, strongly denounce violent attacks against free speech in all their forms, calling instead for  
24 a culture that values life, civility, and free expression of conscience; and be it further  
25

26 RESOLVED, that we encourage all believers to bear courageous witness to the Gospel, to engage the public square boldly  
27 and humbly, and to trust the Lord to use their faithful testimony for his glory (Acts 4:18–20); and be it finally  
28

29 RESOLVED, that we pray for God to raise up men and women of conviction, who will declare the unchanging truth of Christ  
30 with grace and steadfastness, regardless of threat or cost (Acts 4:29–31).

### ***3. Affirming Life and Opposing Drug-Induced Abortions***

3 WHEREAS, every human life, from conception to natural death, is a sacred gift of God, created in his image (Genesis 1:27;  
4 Psalm 127:3–5; Psalm 139:13–16); and  
5

6 WHEREAS, Scripture calls God’s people to defend the vulnerable (Psalm 82:3–4) and to speak up for those who cannot  
7 speak for themselves (Proverbs 31:8–9); and  
8

9 WHEREAS, Christ calls his church to extend both truth and compassion, offering hope, healing, and forgiveness through  
10 the Gospel to all who have been impacted by abortion (John 8:32); and  
11

12 WHEREAS, drug-induced abortions accounted for 63% of all abortions in the United States in 2023,<sup>1</sup> and 84% of all  
13 abortions in South Carolina in 2023 were chemically induced,<sup>2</sup> demonstrating a sharp rise in the prevalence of this  
14 dangerous method for terminating pregnancy within our state; and  
15

16 WHEREAS, drug-induced abortions endanger unborn children while also placing women at increased risk of physical  
17 complications, such as hemorrhage and infection; psychological trauma; and spiritual detachment<sup>3</sup>; and  
18

19 WHEREAS, although drug-induced abortions are often promoted as safe and easy,<sup>4</sup> in reality, they leave women to endure  
20 a painful and sometimes dangerous process, frequently alone and without medical supervision; and  
21

22 WHEREAS, the abortion industry exploits vulnerable women, particularly through online access to abortion-inducing drugs,  
23 by downplaying or disregarding the potential long-term consequences of such procedures on women’s health and well  
24 being; therefore, be it  
25

26 RESOLVED, that we, the messengers to the 205th session of the South Carolina Baptist Convention meeting in Taylors,  
27 South Carolina, November 10–11, 2025, affirm the dignity and value of every human life, both born and preborn, and  
28 oppose the practice of drug-induced abortions; and be it further  
29

30 RESOLVED, that we call upon South Carolina Baptists to support life by praying for, serving with, and financially supporting  
31 pregnancy resource centers, foster and kinship care initiatives, and adoption ministries; and be it further  
32

33 RESOLVED, that we urge lawmakers to protect both the preborn and expectant mothers by promoting policies that  
34 safeguard the well-being of women, encouraging holistic healthcare that values both mother and child, and enacting

35 legislation that prohibits the use of abortion-inducing drugs in South Carolina; and be it further  
36  
37 RESOLVED, that we encourage churches to equip members to evangelize, disciple, and walk alongside women and families  
38 facing unplanned pregnancies, offering compassion, and tangible support in the name of Christ; and be it further  
39  
40 RESOLVED, that we call upon South Carolina Baptists to continue to advocate for a culture of life in every sphere of  
41 influence, resisting the normalization of abortion in all its forms; and be it finally  
42  
43 RESOLVED, that we commit ourselves to proclaim the Gospel of Jesus Christ as the ultimate hope for life, healing, and  
44 restoration for all people (Romans 1:16; 2 Corinthians 5:17–19; Colossians 1:19–20).

#### 4. *Urgency of Personal Evangelism*

1  
2  
3 WHEREAS, Jesus Christ has commanded his followers to “go and make disciples of all nations,” (Matthew 28:19–20),  
4 proclaiming the Gospel message of the atoning death, physical burial, and glorious resurrection of Jesus Christ to every  
5 person (Mark 16:15; 1 Corinthians 15); and  
6  
7 WHEREAS, the population of South Carolina continues to grow rapidly, with the addition of more than 1 million new  
8 residents in the period between 2000 and 2022,<sup>1</sup> and according to the South Carolina Revenue and Fiscal Affairs Office,  
9 South Carolina is the fastest growing state by percentage and the 5th fastest by numeric change; and  
10  
11 WHEREAS, although baptisms have increased over the last five years according to South Carolina Baptist Convention  
12 statistics, the reported number of baptisms annually has decreased over the last decade by almost 5,000; and  
13  
14 WHEREAS, apart from a renewed commitment to genuine relationships with lost people and personal evangelism, we risk  
15 losing ground in fulfilling the Great Commission given by our Savior, and losing an entire generation; therefore, be it  
16  
17 RESOLVED, that we, the messengers to the 205th session of the South Carolina Baptist Convention meeting in Taylors,  
18 South Carolina, November 10–11, 2025, affirm the urgency of personal evangelism as a biblical mandate (Acts 1:8) and a  
19 present necessity; and be it further  
20  
21 RESOLVED, that we call upon every South Carolina Baptist pastor, church leader, and church member to intentionally  
22 build relationships with those far from God and verbally share the Gospel with friends, family, neighbors, co-workers, and  
23 newcomers to our communities; and be it further  
24  
25 RESOLVED, that we encourage each South Carolina Baptist church to prioritize equipping their members to confidently and  
26 compassionately proclaim Christ, by providing training, resources, and accountability in evangelism; and be it finally

27

28 RESOLVED, that we commit ourselves to the mission of Christ's Church, relying on the power of the Holy Spirit to make  
29 Christ known in South Carolina and to the ends of the earth, so that all may hear and believe in Jesus Christ as Lord and  
30 Savior.

### ***5. Dangers of Predatory Gambling***

2

3 WHEREAS, the South Carolina Baptist Convention has a long history of opposing gambling in its various forms, including  
4 casinos, lotteries, horse racing, and other predatory gambling schemes (21 gambling resolutions since 1983); and

5

6 WHEREAS, the South Carolina General Assembly currently has three gambling bills under consideration that would  
7 establish casino gambling, legalize online sports wagering, and permit pari-mutuel betting on horse racing; and

8

9 [Neighborly Love and Predatory Behavior]

10 WHEREAS, predatory gambling violates the principle of neighbor-love, causing the financial loss and harm of many for  
11 the gain of a few who enjoy entertainment at the expense of others (Exodus 20:17; 22:21; Leviticus 25:17; Deuteronomy  
12 22:1-4; Matthew 22:39; Mark 12:31; Romans 13:8-10; Galatians 5:14; James 2:8); and

13

14 WHEREAS, the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders (DSM-5) classifies  
15 gambling as an addictive product similar to heroin, opioids, alcohol, and cocaine; and

16

17 WHEREAS, according to Baylor University economics professor Dr. Earl Grinols, communities typically build casinos based  
18 on a mirage of false promises, such as providing jobs, funding schools, and boosting the local economy, when one of every  
19 dollar of casino benefit to the community generates three dollars in social costs; and

20

21 WHEREAS, no amount of taxation, regulation, or economic gain would justify the harm caused by an expansion of legalized  
22 gambling on individuals, marriages, families, children, economic well-being, and opportunities for human flourishing; and

23

24 [Trusting God Over Government]

25 WHEREAS, gambling violates the principle of lordship, tempting individuals to trust chance rather than God, who provides  
26 for the needs of "the righteous and the unrighteous" (Matthew 5:45; 6:24; Philippians 4:18-19; 1 Corinthians 10:31; 2  
27 Corinthians 9:8-12; Colossians 3:17; 1 Timothy 6:17-18); and

28

29 WHEREAS, studies from institutions such as the University of California, Los Angeles, and the University of Oregon reveal  
30 online sports wagering is highly addictive, increasing incidences of domestic violence, personal bankruptcy, and emotional  
31 and psychological problems such as anxiety, depression, and suicide; and

32

33 [Principles of Work]

34 WHEREAS, gambling violates the principle of work by looking to gain something for nothing and hoping for easy money  
35 rather than pursuing responsible industry, investment, and labor (Genesis 1:28; Exodus 20:9; Psalm 104:23; 128:2;  
36 Ecclesiastes 2:24; 1 Thessalonians 4:11-12; 2 Thessalonians 3:7-12); and

37

38 WHEREAS, a 2024 study conducted by Northwestern University on the negative financial effects of sports wagering  
39 concluded that while online sports betting may offer states an additional source of revenue, it also exposes residents,  
40 especially those already facing financial difficulties, to significant financial risks; and

41

42 WHEREAS, according to a 5-year study conducted by the University of California San Diego that included data from 32  
43 states and over 700,000 gamblers, 96% appeared to lose money compared to only 4% who made money; and

44

45 [Principles of Stewardship]

46 WHEREAS, gambling violates the principle of stewardship, encouraging reckless and careless speculation with resources  
47 entrusted by the Lord while disregarding the same Lord who provides for all human needs (Matthew 6:19–34; 1 Timothy  
48 6:17–18; 1 Peter 4:1–11); and

49

50 WHEREAS, according to an extensive investigative essay in *The Atlantic*, casinos build their business model on problem  
51 gamblers and employ tactics, such as identifying their “biggest losers” and offering them customized perks and VIP  
52 treatment; and

53

54 [Principle of Violence]

55 WHEREAS, the Bible clearly identifies violence as a corrupting force in society, declaring that “the violence of the wicked  
56 sweeps them away, because they refuse to act justly” (Proverbs 21:7) and that “the Lord examines the righteous, but he  
57 hates the wicked and those who love violence” (Psalm 11:5); and

58

59 WHEREAS, research published by Birches Health recognizes that up to 50% of people with a gambling addiction have  
60 committed a gambling-related crime (theft, fraud, or embezzlement) and it is linked to suicidality and intimate partner  
61 violence<sup>1</sup>; and

62

63 [Civil Magistrate & Current Legislation]

64 WHEREAS, gambling violates the principle of the civil magistrate, causing governments to prey on their own citizens  
65 through state-sponsored gambling rather than protecting them and seeking their good (Proverbs 8:15–16; Amos 5:10–13;  
66 Romans 13:4; 1 Timothy 2:1–2; 1 Peter 2:13–15); therefore, be it

67

68 RESOLVED, that we, the messengers to the 205th session of the South Carolina Baptist Convention meeting in Taylors,  
69 South Carolina, November 10–11, 2025, encourage the members of the South Carolina General Assembly to stop all efforts  
70 to open South Carolina to additional legalized gambling; and, be it further

71

72 RESOLVED, that we encourage all South Carolina Baptists to contact their legislators to express their opposition to the  
73 expansion of all forms of gambling; and be it further

74

75 RESOLVED, that we encourage our state legislators to stand up and oppose efforts by representatives of gambling  
76 interests who seek to exert their influence over the political process, portraying predatory gambling as a means to  
77 strengthen the economy and to promote human flourishing; and be it finally

78

79 RESOLVED, that a copy of this resolution be provided to all members of the South Carolina General Assembly.
